

## Safety, Security, and Environment Protection Policy

We at Veresen Midstream (Veresen) are committed to working in a responsible manner, one that promotes the well-being and protection of our workers, the public, and the environment. Our goal is no accidents, no spills, no ruptures, no harm to people and no damage to the environment.

To achieve this goal, Veresen shall ensure that its facilities are designed, constructed, operated, and maintained in a manner that protects the health, safety, and security of our employees, contractors, customers, communities, and the environment in which they operate. Veresen is committed to ensuring that:

- Compliance with health, safety, security, integrity, damage prevention, and environmental rules, regulations, and approvals come first, regardless of the magnitude or urgency of the job.
- Safety, security and environmental hazards are assessed for all Veresen facilities and activities, and that appropriate hazard controls are established to reduce the risks to acceptable levels.
- Personnel are available to provide the resources and guidance necessary for monitoring and continuous improvement of safety, security, environment, integrity, damage prevention and emergency management programs and practices established by our contract operator.
- Our employees and contract operator are equipped with the knowledge, tools and training necessary to allow them to conduct their work in a healthy, safe, secure, and environmentally productive manner.
- The internal reporting of hazards, potential hazards, incidents and near misses is completed in an efficient and timely manner, and that any person making a report is granted immunity from disciplinary action.
- We consult, listen, and respond respectfully to our contract operator, customers, suppliers, employees, neighbors and regulators with clear intent to deliver our commitments.

### Principles

Veresen believes that the health, safety and well-being of our employees, contractors, customers and the public are of the utmost importance. It is our goal to operate our business in such a way as to prevent harm to people and to protect the environment.

#### Health and Safety

- Every worker employed on a Veresen work site has the right to a healthy and safe environment. Veresen embraces a 100% compliant healthy and safe culture and places the protection of people from injury above all other management considerations. Our goal is an incident free workplace.
- Prior to the commencement of any work by our contract operator, safe work practices to manage the hazards to people and the environment shall be developed, implemented, and continually updated so that they are followed.
- Workers shall be trained, coached, and supervised; and personal protective equipment always worn.
- Hazards, potential hazards, near misses and incidents shall be reported. All near misses and incidents shall be investigated.

#### Security and Emergency Response

- Veresen and its contract operator shall assess security risks and establish appropriate practices to manage the risks.
- Security and emergency response plans appropriate for the operations shall be established and tested regularly, so that Veresen and their contract operator are prepared to respond to abnormal events.
- Communications with government agencies, emergency responders, and stakeholders shall be established by Veresen and their contract operator to identify possible areas of impact, and any potential concerns addressed.

#### Environment

- Veresen is committed to responsible stewardship of the environment at our worksites and the continual improvement of our environmental performance.
- Veresen and its contract operator shall establish sustainable business practices that prevent pollution, minimize impacts to the environment, and manage waste safely and responsibly.
- Veresen and its contract operator shall respond to, and remediate, environmental damage resulting from spills and gas releases in a timely and responsible manner.

#### Integrity and Damage Prevention

- Veresen and its contract operator shall establish an Integrity Program and Damage Prevention to ensure the safe operation of Veresen's assets.
- Veresen and its contract operator shall construct, operate and maintain Veresen's assets in a manner that protects the public, employees, the environment, and the communities in which we operate.
- Veresen and its contract operator shall apply competent technical and operational risk assessment processes to evaluate assets and ensure operations comply with regulatory requirements.

#### Assurance

- Veresen shall establish a quality management system that ensures Veresen's assets are designed, constructed, operated, and maintained in compliance with regulatory requirements.
- Veresen shall ensure that the contract operator has established an operational management system that meets regulatory requirements, is in alignment with Veresen's Principles, and will achieve our objectives and goals.

The success of Veresen achieving its goal depends on the adherence and cooperation of all Veresen employees and the contract operator to these commitments and principles. We shall all strive to protect the health and safety of ourselves, fellow workers, general public and the environment. Delivering on the Veresen goal is the core accountability of the management team of Veresen.
